## Fact Sheet: Computer Programs and the Food Safety program Records

Dairy Farmers of Canada is pleased that a number of computer software companies have included all or part of the Food Safety program record keeping requirements in their dairy herd management software programs, enabling farmers to keep the records electronically.

The Food Safety program offers to review any software program that requests a review. The Food Safety program simply reviews the software to determine if it enables a farmer to enter all of the required record keeping information.

The Food Safety program recognizes two categories of compliance: complete and partial. A software program has to contain at least one complete record to be included on the partial list. If a company has not requested a review, it will not appear on either list; therefore, the lists may not be complete. The Food Safety program relies on the companies listed below to inform it of any changes they make to their software programs in order to keep this list current.
