An overview of the WTO negotiations on agriculture

## **WTO Director General Selection Process**

The WTO full membership gathered on March 19<sup>th</sup> to review the process of appointing the next Director General to replace Pascal Lamy. The informal General Council meeting led by its new chair, Pakistan's Ambassador to the WTO, Shahid Bashir, was aimed at clarifying how the committee – composed of the Dispute Settlement Body's chairman, Canadian ambassador Jonathan Fried and the Trade Policy Review Body's chairman, Sweden's ambassador Joakim Reiter – intends to proceed, through a series of consultations, to narrow the field of candidates and ultimately select a new director General.

"[T]he ultimate aim of the consultation process shall be to identify the candidate around whom consensus can be built," Bashir told the membership. In order to do so, the committee plans to hold three rounds of consultations, with a possible fourth one to arrive to a consensual candidate.

The first round scheduled to start the week of April 2 will seek to eliminate 4 of the 9 candidates from the race. WTO Members will be asked to identify the candidates least likely to attract their support for the job. The second slated to start shortly after the April 9 – when the results of the first round are known – will seek to eliminate three more candidates. As such Members would be asked to select their two preferred candidates likely to attract consensus to go head to head in what should normally be the third and final round before the process is concluded with a General Council meeting to be called by May 31<sup>st</sup> at which point the new Director-General would have to be appointed.

Because "unexpected circumstances" may occur depending on Members' preferences, a fourth Round may be necessary, the committee said.

Nine candidates are running for the WTO top job with two coming from Africa - Mr Alan John Kwadwo Kyerematen, Ghana's former Trade Minister and Ms Amina Mohamed from Kenya who has chaired three WTO bodies (Dispute Settlement Body, Trade Policy Review Body and General Council) during her tenure as Kenya's Ambassador to the UN in Geneva from 2000-2006.

The Latin America continent has 3 candidates - Ms Anabel González, Costa Rica's current Minister of Foreign Trade who has been Director of the WTO Agriculture Division between 2006 and 2009. She is joined by Mexico's former Minister of Trade and Industry, Mr Herminio Blanco, and current Brazilian ambassador to the WTO, Mr Roberto Carvalho de Azevêdo.

Two candidates originate from Asia – Indonesia's former Trade Minister, Ms Mari Elka Pangestu, and Korea's former Trade Minister Mr. Taeho Bark.

The last two candidates are New Zealand's Trade Minister, Mr Tim Groser and Former Minister of Industry and Trade of Jordan, Mr. Ahmad Thougan Hindawi.
